The Zilla Way Award was created by the LWV ABC board in 1996 to honor a local League member who has provided outstanding leadership in guiding our organization. It was named after current member, Ms. Zilla Way, for her more than 60-year participation in League and her role as LWV ABC mentor and advisor.

On the backdrop of an early suffragette, Sandra's accomplishments that are incorporated in the painting and include:

- Stepping up as a new member to chair the Membership Committee, adding her expertise to our board
- Initiating and leading the collaboration of an exhibit at the Anoka County History Center, honoring the 100th anniversary of LWV US and honoring women of achievement in Anoka County.
- Welcoming visitors to our monthly programs and helping them find a home for their talents in LWV ABC
- Accepting the challenge and training to become a moderator for a full schedule of fall forums that was challenging our capacity
- Organizing, leading, taking informed action skills and kindness that inspire us.

Full Delegation from LWV ABC Attends LWV Minnesota Convention in St. Paul

It was a full weekend of workshops, elections, important updates, establishing Programs for Action, hearing about LWV MN resources that will support local Leagues in celebrating the 100th anniversary of League, and learning from other Leagues. The ballroom at the St. Paul Hotel was filled with inspiring men and women.

In attendance from LWV ABC were Gretchen Sabel, Susan Anderson, Darby and Geri Nelson, Kathie Whelchel, Kathy Aanerud and Rochelle Turan.



Some highlights from the convention:

Virginia Case - LWV US CEO gave the keynote. She started off by reading text from Clara Ueland plaque at Capitol (see photo on following page). Some quotes: Leadership does not bring more privilege, it brings more responsibility. She loves that the League is non-partisan, and that our positions are based on studies and facts. "The league is not beholden to any party. The League is beholden to the American people."

Virginia then talked about the LWV US board decision to oppose Cavanaugh nomination to US Supreme Court. Would this jeopardize our nonpartisan policy? No, judges are not partisan so opposing is not partisan act; LWV US opposed Cavanaugh based on lack of judicial temperament, as evidenced in his responses to Senator Klobuchar, They looked at the past, when LWV was late in weighing in on the 'right side' of issues like votes for people of color, opposition to Vietnam war, endorsing the ERA. The new League direction is to take action. Virginia got arrested at Cavanaugh protest, had the ok from LWV US board to participate. News coverage, especially by Breitbach, resulted in online trolling, which was hard for her.



In the question session, Virginia was asked about ranked choice voting. She told us that LWV US is trying to get a grant to study this. LWV Maine did a study on this from their perspective.

A couple leagues raised concerns about LWV's nonpartisan policy since we are perceived as liberal Dems. Does LWV want people to belong who agree with our positions, or does LWV want open discussion and diversity of thought? This can conflict with "speak with one voice". The answer is to engage in discussion and maybe change the positions.

When our LWV MN leaders took the stage, Executive Director Michelle Witte told us that LWV MN is "Purposeful and Relevant and our work is purposeful, strategic, and done with integrity." She noted that we had a 20% increase in membership - now at 2074 members statewide. LWV MN is launching a new "sustained giving" campaign, with a goal of 10% of members as sustainers. Five special events for the Centennial (more on that in upcoming newsletters).

Shelley Colvin, director of Diversity, Equity and Inclusion, told us that LWV MN will be having the "big read" - statewide LWV book club on diversity topics. Each League was given the book "Waking up White" to start things off.

Lynn Theurer, Membership/Leadership Director said that the website redesign is now done – check it out. She stated that Grace Riley is willing to come out and show folks around Google docs. We should take her up on this to improve our collaboration and effectiveness.

Laura Helmer, Voter Service chair, talked about failed attempt to have an LWV gubernatorial candidate forum. The process was successful - partnership with TPT and several ethnic councils were formed even though candidate intransigence prevented the forum from happening. Zandy Zweibel, new LWV MN Treasurer, noted that LWV US reported about 600 forums nationwide; MN accounted for 120 of these, about 20%. More than 8000 new citizens registered in the last year.

Britt Heglund, Action Chair, told us that the time is now to call your state Senator and ask them why HAVA election funding is being held up. Especially for those with Republican Senators.

Geri Nelson Honored with award at LWV State Convention

A particular highlight of the convention was cheering for Geri Nelson, current and longtime member of LWV ABC, when she was presented with the Hope Washburn Award. The Hope Washburn Award was established in 1956 to honor the service Hope Washburn gave to the St. Paul and Minnesota LWVs. The award is presented at Convention to the Minnesota member who has performed outstanding service to LWV Minnesota.

A few of Geri's many accomplishments that were highlighted in Geri's nomination include:

- Mentoring new and younger members and strategizing how we can make League activities more accessible to them;
- Serving our local League and LWV Minnesota as an energetic Voter Service Chair, expanding training and mentoring for new forum moderators, and serving as a well-respected forum moderator herself;
- Serving our local League as board member, president for two non-consecutive terms, and leading local, state, and national studies and projects;
- Co-leading a significant, ambitious, challenging and successful fundraising campaign, "Be: Part of the Conversation," for LWV Minnesota;
- Being engaged in her community as a co-founder of a pollinator protection group in Champlin, excelling
 in teaching science in the Anoka-Hennepin District, organizing and teaching an Eco Kids Camp at her
 church along with leadership positions with stewardship, ushering, pastoral care, pastoral transition and
 more;

Geri tied all these activities together when she told a reporter who was writing about their philanthropy and community service: "Defending voting rights and good government is essential to all the other issues we care about."







Presenting the award to Geri were Virginia Case, CEO of the League of Women Voters of the United States and keynote speaker at the convention and Carol Frisch, LWV Edina (past award recipient). Geri's husband, Darby, was in attendance; and our local president, Gretchen Sabel, was among the first to congratulate Geri.

The Anoka County Administrator – the continuing saga

Long-time Anoka County Administrator Jerry Soma has retiring, effective May 1, 2019. The County Board considered two competing resolutions at their March 26 meeting. The first initiated a low-key internal search for candidates, the second appointed current County Board Chair Rhonda Sivarajah to the post. This letter provides LWV ABC's position on this process. (No surprise - we are in favor of an open, competitive process!) County Commissioner Letter March 22, 2019

At the March 26 Board meeting, the Board deadlocked and was not able to move forward on either resolution. On April 2, the County Board met in a work session to discuss options. Here they decided to have a limited competitive process, where internal candidates including elected officials and recently departed staff could apply. Following this process, the 24 applicants were screened by Anoka County HR staff and then the top three candidates were interviewed by a committee of Board members including Commissioners Schulte, West and Gamache. After the interviews, this committee voted two-to-one to endorse Rhonda Siverajah for the post. We will discuss this at our May 13 meeting; the decision of the full Board is scheduled for May 14. LWV Observers will be on hand for the May 14 meeting of both the Management Committee and the County Board.

We will also give an update on the vote for the Connexus Board at our May 13 meeting.

Water Action Day Report

April 10, 2019 – State Capitol, Senate Office Building, State Office Building and environs

Minnesota's 2019 Water Action Day was held on April 10 in a driving blizzard that shut down much of the state for a day. A bus full of people from Marshall turned around and went home (made it to Redwood Falls) and another bus left early due to weather. Other than that, the day generated a lot of enthusiasm from people around the state who attended the event and lobbied their legislators on clean water. Estimated attendance, even with the bad weather, was about 470.

Drafts and Discourse

Anoka County Commissioner Mandy Meisner spoke April 29, 7pm

Torg Brewing, 8421 University Avenue, Spring Lake Park

Drafts and Discourse is usually on the third Monday of the month. But in April, we took advantage of the fifth-Monday – and Anoka County Commissioner Mandy Meisner was our speaker. We had an informal crowd of about 15-20 people, with some coming and going during the session. Commissioner Meisner talked about her first 100 days in office – the first non-Kordiak to hold this seat in 60 years.

Commissioner Meisner talked about how she developed her brand as a politician after most of her career in non-profits. She had planned to keep a low profile at first, but at about 60 days into her term she was tested when the county administrator position filling debate came up (see related story on

page 6). Commissioners Meisner and Gamache both advocated for a broader process. In the end, Commissioner Meisner said that she listened to her district, and people wanted an open, transparent process. Downside of process that was adopted is that is does not include outside candidates and not the whole board on interviews.

She makes sure to meet with each of her cities quarterly, and she holds listening sessions at least once a year. And does events like this. Commissioner Meisner's long term goals - crisis center for mental health, promoting diversity and inclusion. Women in politics... more needed! Not just



in office but in support roles. She says that women need to be asked to run seven times before they say yes, but it only takes one 'ask' for men to step up.

Commissioner Meisner introduced K.T. Jacobs, who's in charge of the Columbia Heights Complete Count Committee for the 2020 census. Columbia heights and Fridley were both undercounted cities in 2010. She urged us to join a complete count committee. KT noted that all census forms will be online this time, with only limited availability of paper forms so this will be very challenging for some. LWV can help people learn how to access the form.

Many thanks to Commissioner Meisner for her remarks!

Highlights of LWV ABC Board Meeting, April 22, 2019

The Board discussed the need for a strong focus on programming for next year's activities and meeting topics. There are many things to consider in our attempt to make our League a more dynamic, exciting, and effective organization. We may want to add daytime meetings in the winter months in addition to our Monday evening meetings. We may want to look into having a student intern to help with high school voter registration.

One big change we discussed was creating a separate Action Committee, whose task would be to monitor and integrate activities from the three levels of League: Federal, State, and Local. For example, someone could scan emails from the Federal League, and report on when it might be time to call our congressman. Or, at the State League level, when is League Lobby Day, and what topics are being considered. We could then tailor our local meeting topics to coordinate with that information.



LWV Celebration of the 100ths Anniversary of the 19th Amendment


Be part of the LWVMN Centennial - watch this two minute video!
